The Harrison County school system provides school bus transportation for all students attending Robert C. Byrd High School and we encourage you to use this service. However, we do realize that this service is not always practical especially for seniors. Because some students have violated our driving policy in the past it has become necessary for us to make changes in our policy. **The safety and security of the students at RCB is of utmost concern to us.**

RULES AND REGULATIONS

- Seniors will be allowed to apply for parking passes first and then juniors. Permits are not to be given or obtained for other students. Permits are not to be shared, traded or otherwise used by anyone other than the assigned owner.
- Parking spaces will be numbered and students will be assigned a specific space by the principal.
- The row of spaces located adjacent to the sidewalk in front of the PE/health classrooms are off-limits for student parking.
- All students must follow the designated flow of traffic when entering and exiting the parking area.
- Students must occupy only their assigned space (no diagonal parking).
- It is the responsibility of the student to notify the administration if the make or type of vehicle they drive changes.

STUDENTS MAY LOSE DRIVING PRIVLEDGES FOR LEAVING SCHOOL WITHOUT PERMISSION AT ANY TIME DURING THE SCHOOL DAY (including lunch, closed campus). ONCE A STUDENT ARRIVES AT SCHOOL, STUDENT IS TO REMAIN IN SCHOOL UNTIL THE END OF THE DAY. STUDENTS ARE NOT TO VISIT THEIR VEHICLE OR ANY VEHICLE DURING THE DAY WITHOUT PERMISSION.

I understand that I must observe and comply with all parking area rules and regulations as set forth by the Harrison County Board of Education and the school principal. I further understand that I must provide access to the interior of this vehicle to school officials when in their judgment the vehicle may contain any contraband item or items detrimental to the orderly operation of the school and I hereby consent to the search of such vehicle by them without a warrant or other authority. By the signatures on this form, I agree to comply with these regulations or forfeit the privilege of driving a vehicle onto school property.

All rules and regulations as set forth by the State Department of Education, Harrison County Policy JGFF-R (Student Driving) and Robert C. Byrd High School Administration will be strictly enforced. I agree to comply with the rules and penalties set forth in this document.
